ctually, my account of ontopoiesis is an eco-phenomenology. Ontopoiesis reaches to the very germs of ecology: development and genesis. I have published several essays related to this. In The Passions of the Earth [Analecta Husserliana, Vol. LXXI]. I show how the human being is an ecological fruit and how the human being is formed by the earth and sucks the juices of the earth. I have also written things about the cosmos and the cosmic dependencies of the human mind and human development. You see, the self-individualization of life, which is the basic instrument of ontopoiesis draws upon the laws of the cosmos and the earth. This is the most fundamental ecology that can be done. So, we have just touched the essence of my philosophy, the base - our relationship to the earth and to the cosmos.
